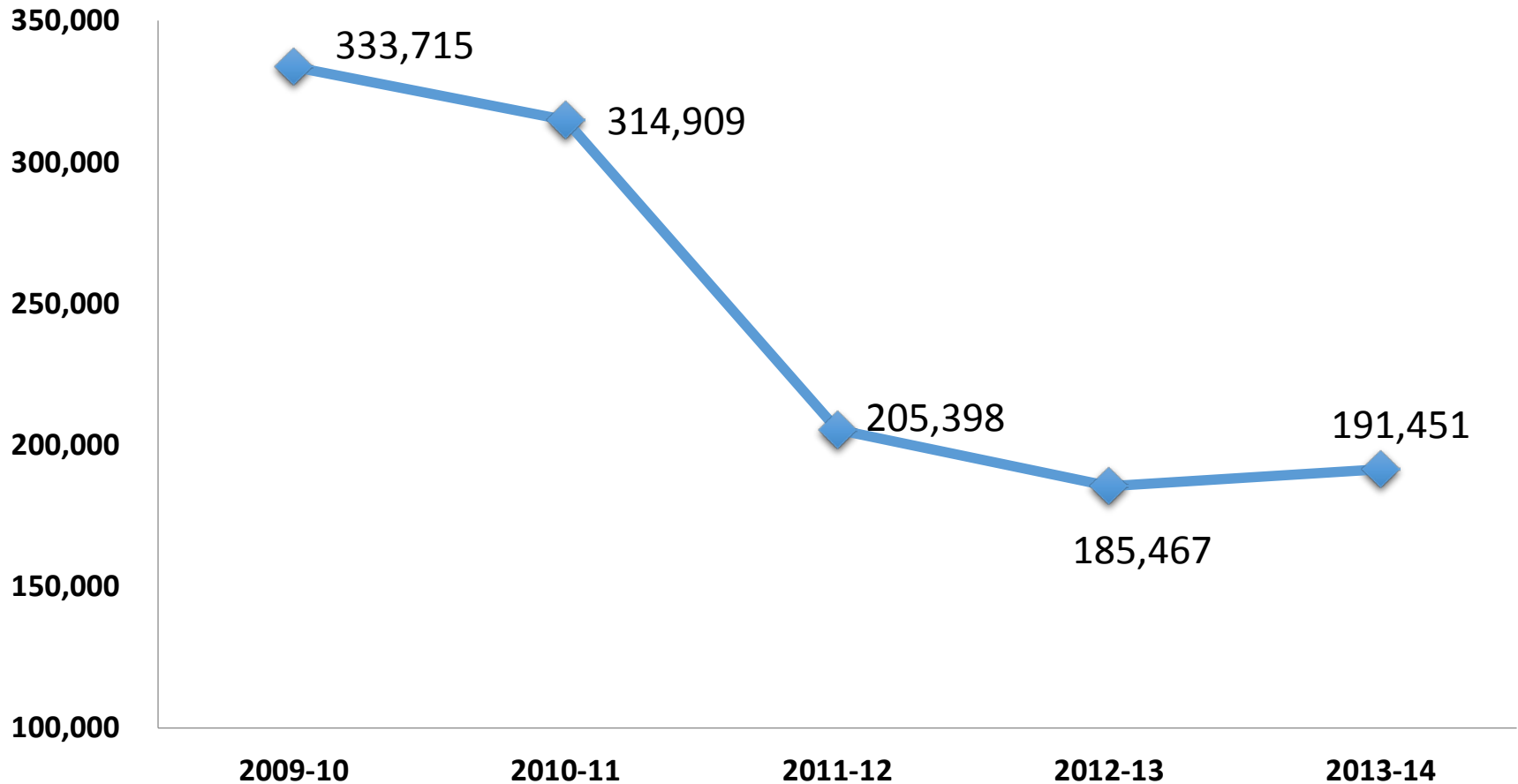

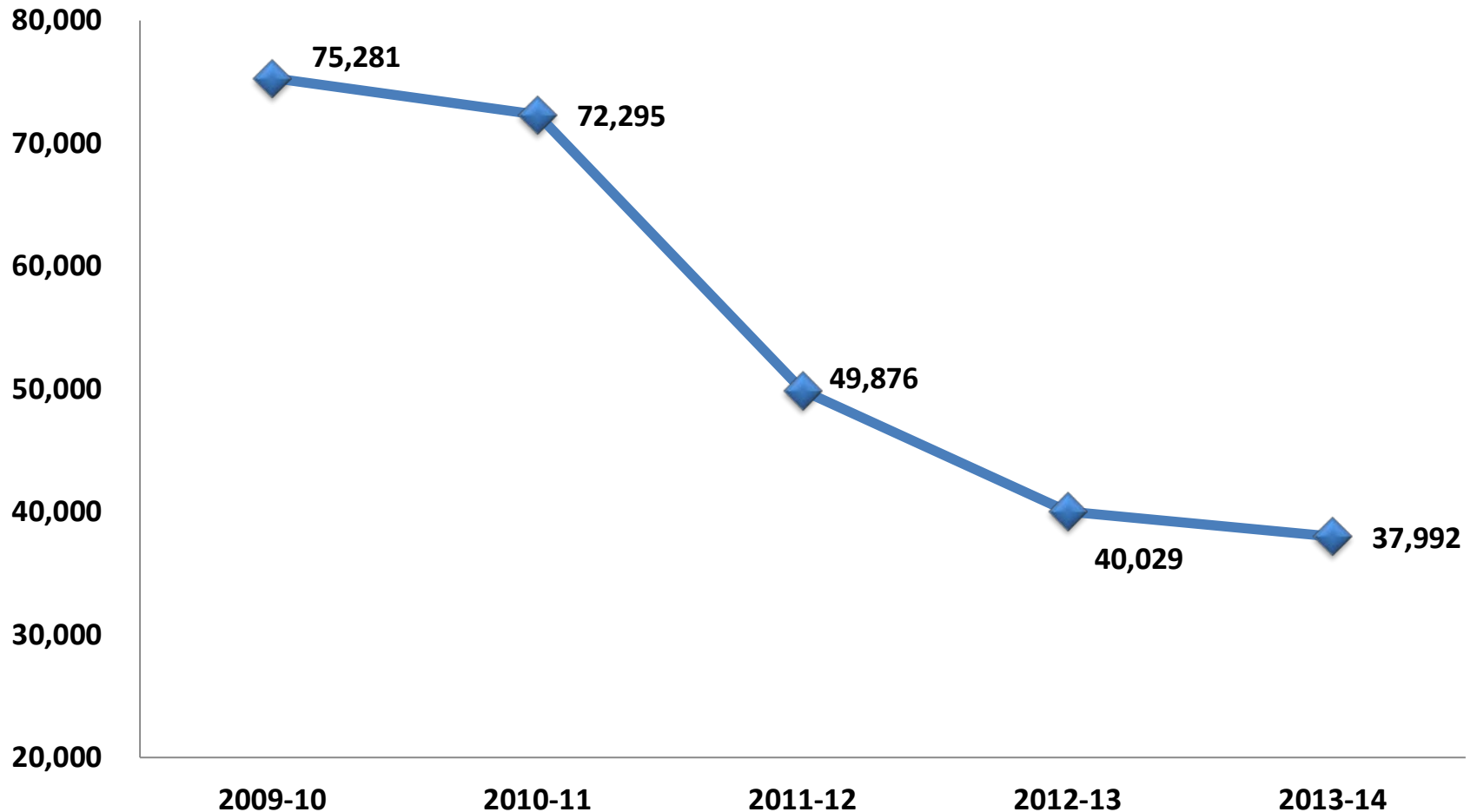
Adult Education

- The Florida Department of Education is committed to improving, expanding and creating adult education programs that include adult education career pathways and transitioning opportunities to postsecondary programs

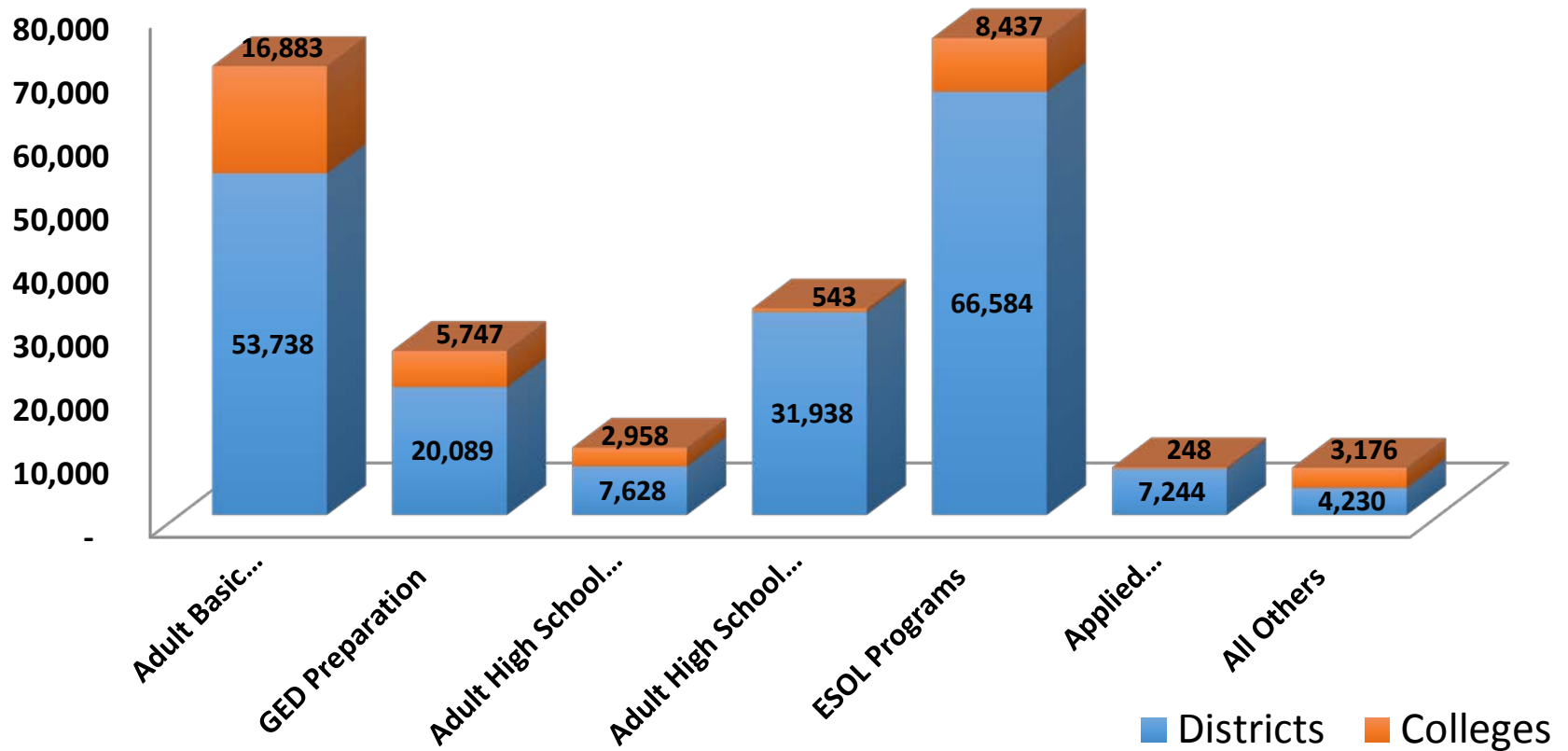
School District Adult Education Enrollment 2009 to 2014



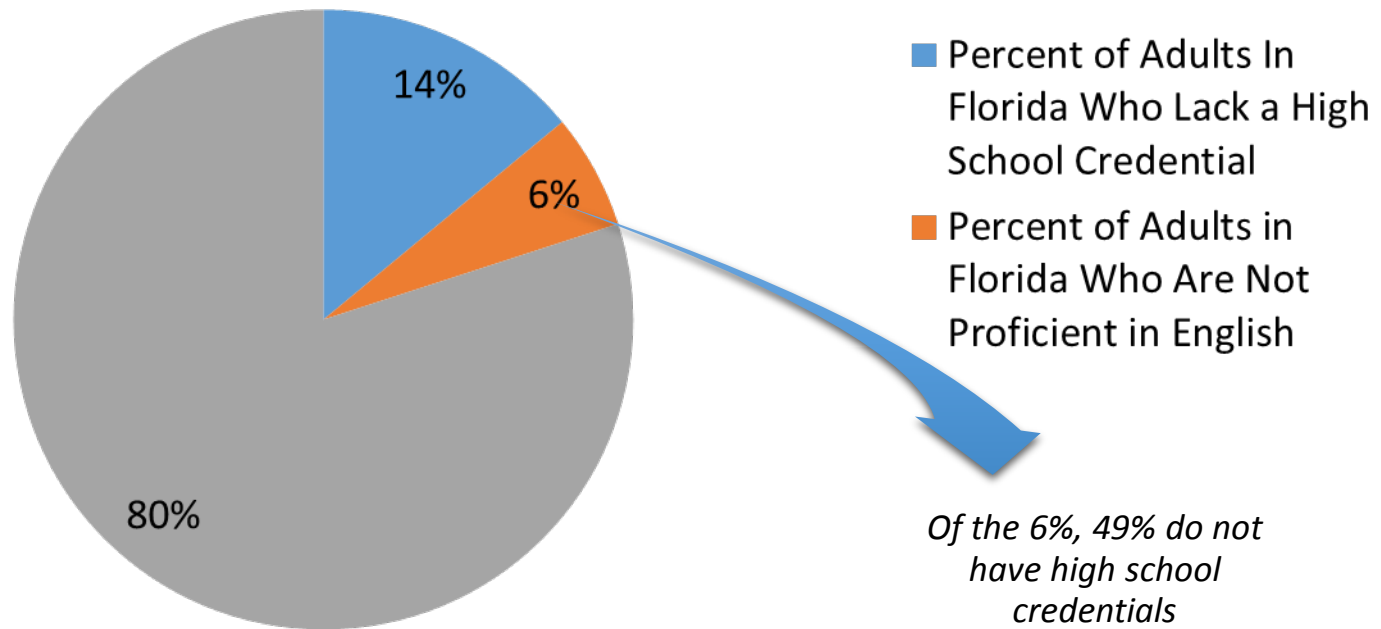
Florida Colleges Adult Education Enrollment 2009 to 2014



District and College Enrollments in Adult Education Programs 2013-14

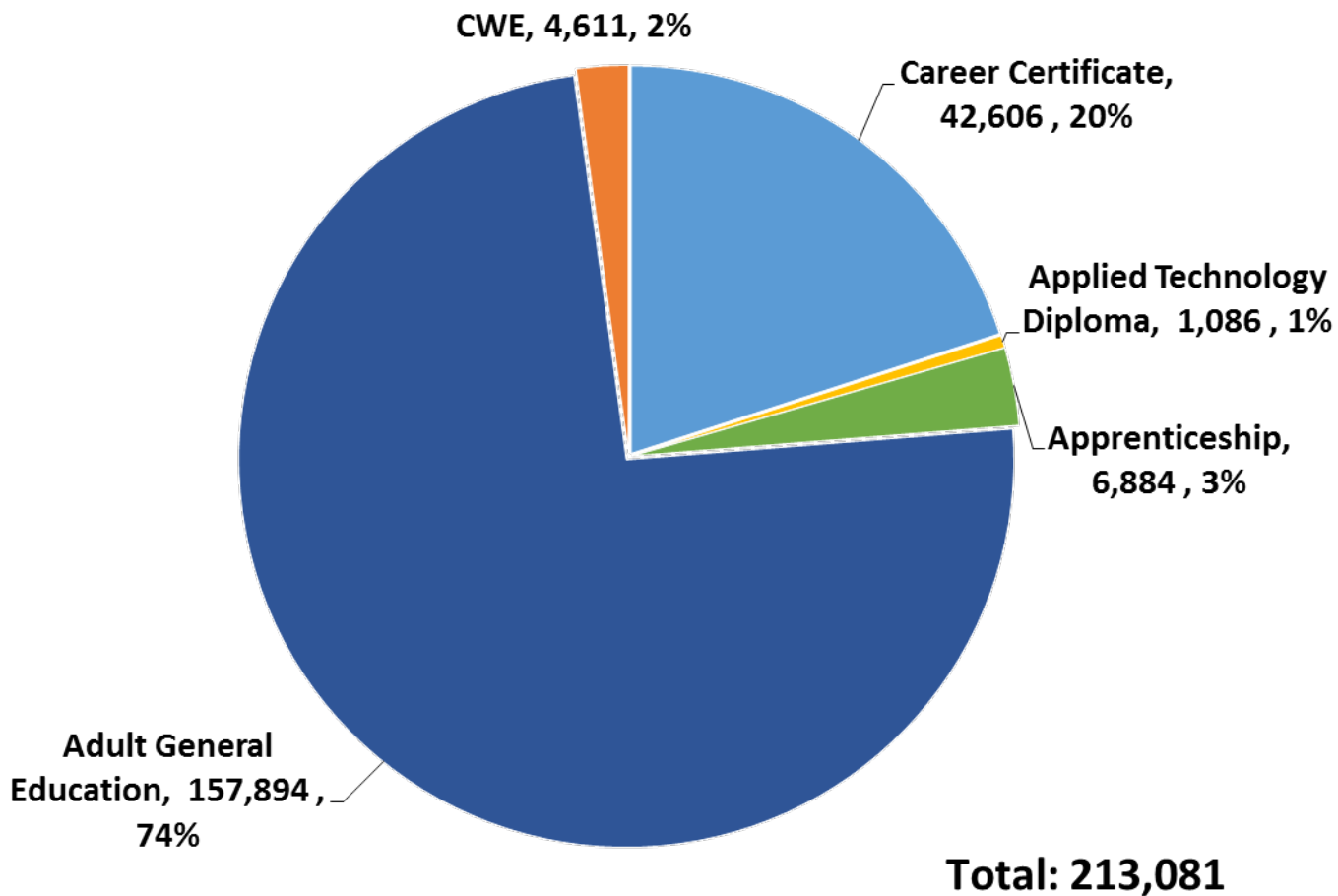


Increase the number and percentage of adult education students who enter postsecondary education

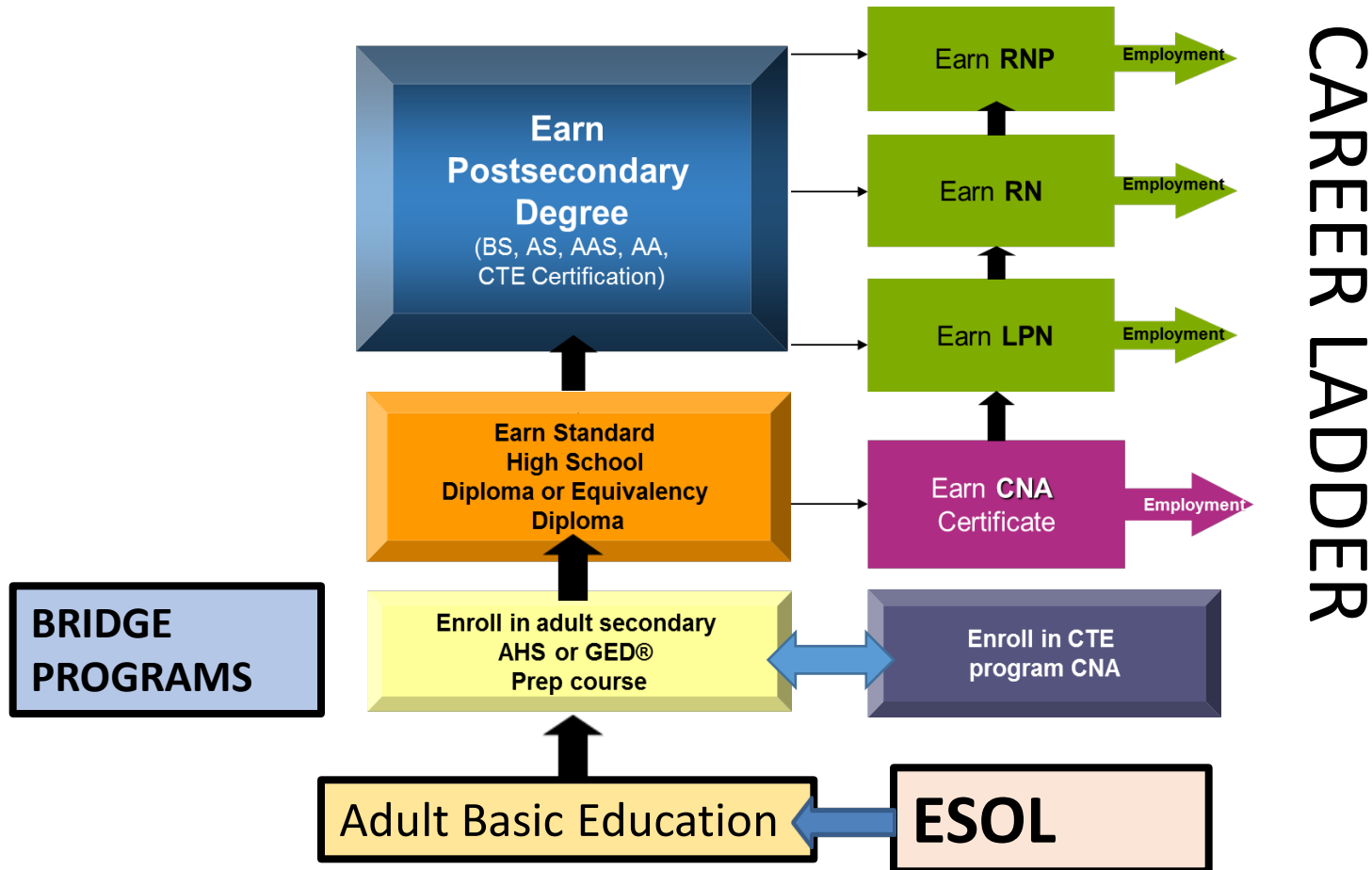


By the end of this decade, two out of three job openings will require some postsecondary education or credential

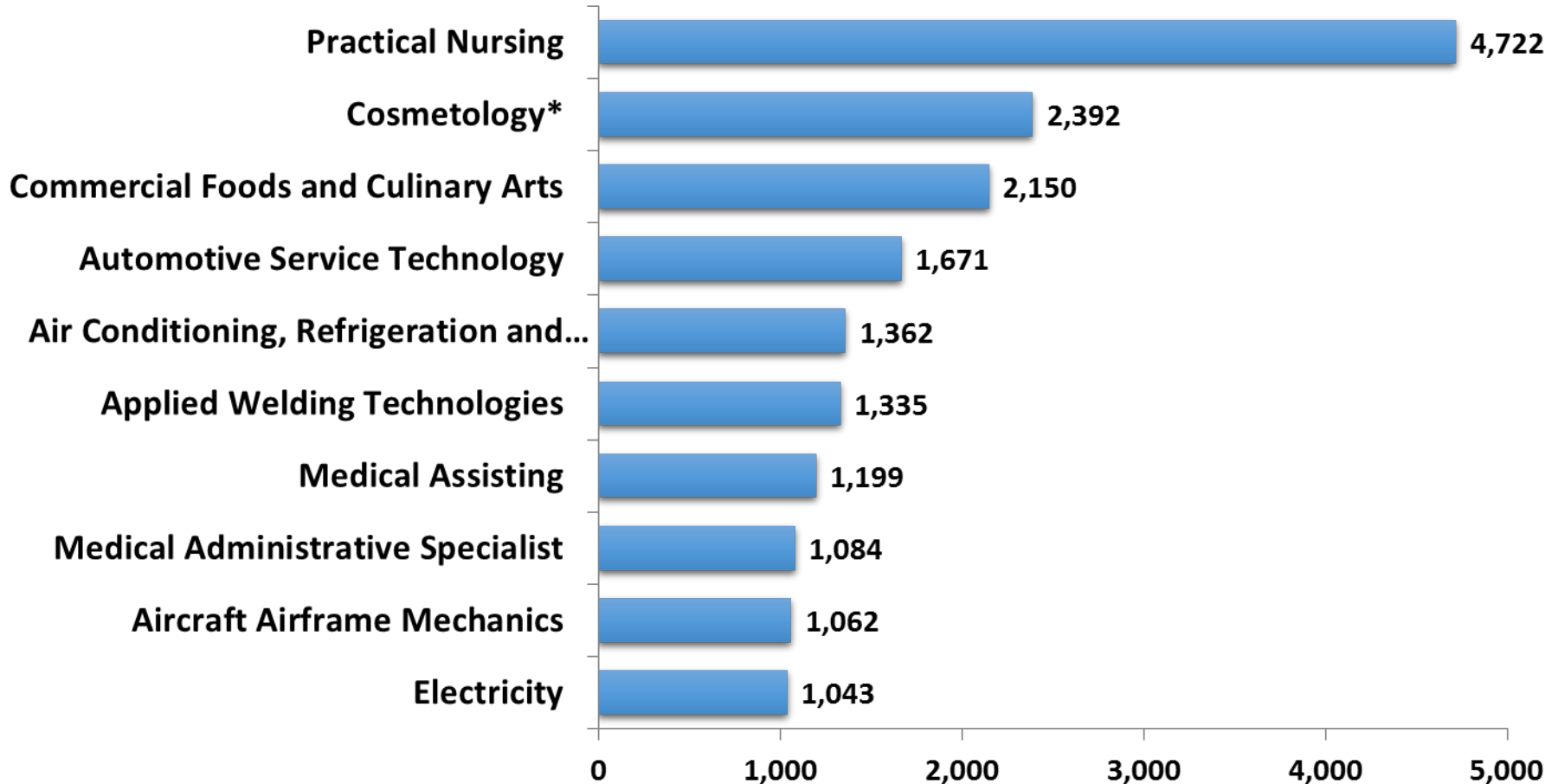
Postsecondary Statewide District Career and Adult Education Headcount by Program Area



Career Pathway with Adult Education and CTE Program Enrollment



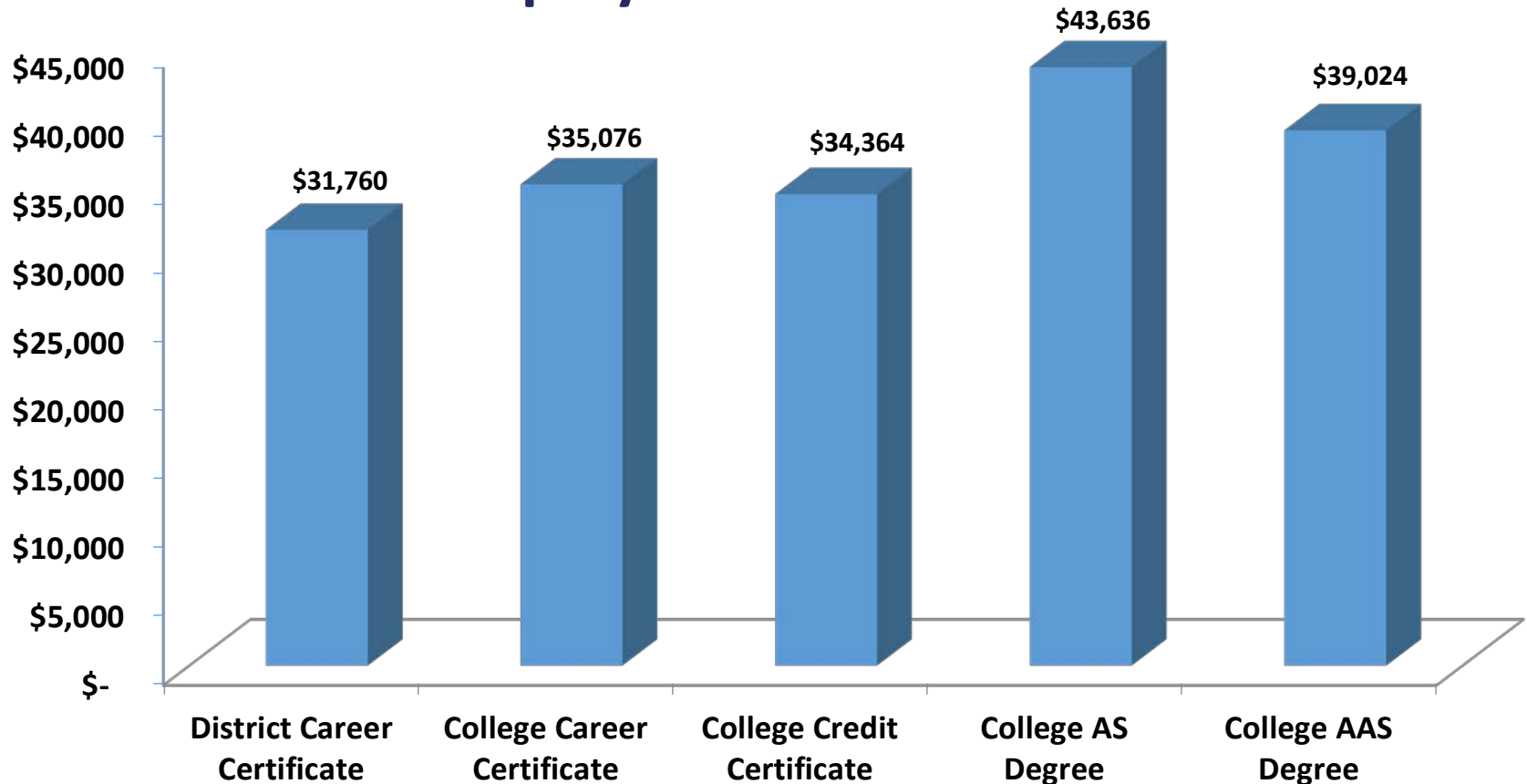
District Workforce Education Top 10 Career Certificate Enrollments, 2013-14

Workforce Innovation and Opportunity Act (WIOA)

- Adult Education in Florida has operated under the Workforce Investment since 1999-2000. In July 2014, President Obama signed the Workforce Innovation and Opportunity Act (WIOA), which supersedes the Workforce Investment Act of 1998 and amends the Adult Education and Family Literacy Act. The transition year will be 2015-2016. The draft regulations will be released this spring.
- WIOA promotes transitions from adult education to postsecondary programs and training through the career pathways system.

Ability to Benefit

- Definition of an Ability-To-Benefit Student

A student who is beyond the age of compulsory education, lacks a high school diploma or its equivalent, and has the ability to benefit from the education or training offered at an institution.

- Ability to Benefit available to students who enroll in a career pathways program
- The Career Pathways Program:
 - Concurrently enrolls in connected adult education and eligible postsecondary programs.
 - Aligned with the education and skill needs of the regional economy
 - provides counseling and supportive services to identify and attain academic and career goals

WIOA and the 2015-2016 AGE Grant Process

- **Changes in the Adult General Education Grant Application for 2015-2016.**
 - Once the regulations are available, we will schedule series of meetings regarding WIOA seeking public input on the state unified plan.
 - The Act contains changes that effect how states will compete funds to local adult education agencies.
 - The definition of “eligible provider” increases the importance of all eligible applicants having “demonstrated effectiveness” in providing adult education and literacy services.
 - The list of eligible providers under WIA was a definitive list of providers who could apply for funds. WIOA contains provisions that make any organization of “demonstrated effectiveness” eligible to apply for funds.

New Funding Opportunities

- Request for Proposals for ***Building and Implementing Bridge Programs and/or Education and Training Programs*** will be released this spring
 - Competitive process
 - Tentative plans – 10 grants to be awarded in the amount of \$25,000 each
